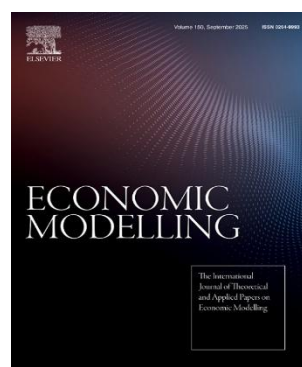
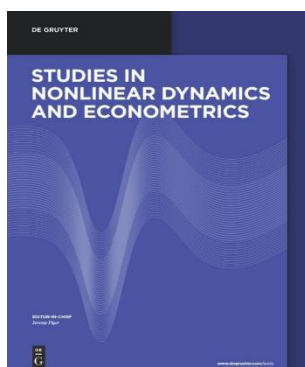

Please note that submission fees and publication policies vary by journal, and authors are responsible for complying with the terms, including any applicable fees, set by the journal to which they submit. No extensions will be provided. We aim for a quick turnout in all cases.
